

*Limited Warranty:* Your Raymond Renewed material handling limited warranty provides fork-to-bumper coverage for thirty (30) days from its installation. Fork-to-bumper coverage provides warranty against defects in materials and workmanship and all service adjustments (minor repairs not usually associated with replacement of parts) but expressly excludes scheduled maintenance and wear and tear. Your Raymond Renewed material handling equipment major components are also warranted against defect in materials and workmanship for one-hundred and eighty (180) days from installation of the material handling equipment. *(12-month warranty available upon request).*

For purposes of this limited warranty, major components are Vehicle Manager Steer Motor, Pump and Actuator Traction Power Amplifier Auxiliary Motor and Pump Traction Motor Lift Power Amplifier Drive Unit Lift Motor and Pump Major components found to be defective by an authorized RS&SC during the warranty period will be replaced or repaired at the sole discretion of the authorized RS&SC. The authorized RS&SC reserves the right to replace major components with reconditioned or replacement units. Replacement or repair of major components and service adjustments will be made by an authorized RS&SC during normal business hours (no overtime premium will be paid.) Incidental charges for emergency delivery, installation or interim rental equipment will be your responsibility. Additionally, freight charges for parts involved in the replacement or repair of a defective major component will be paid by the RS&SC, provided that the replacement or repair is made by an authorized RS&SC. Local taxes, if any, are excluded.

This limited warranty excludes scheduled maintenance and wear and tear (as determined by an authorized RS&SC) and except for the fork-to bumper coverage, service adjustments, oil leaks or loose hardware.

Notwithstanding any other language contained herein, this buy back guaranty and limited warranty are void in the event of defects or damage caused by a) lack of scheduled maintenance (as described in the Maintenance Manual and Raymond Service Information), b) misuse, abuse, accident, or impact as determined in the opinion of an authorized RS&SC, c) if all repairs and maintenance on the material handling equipment are not performed by an authorized RS&SC and other than genuine Raymond parts are used in that repair and maintenance, or d) modifications are made to the material handling equipment or additional components or devices are added to the equipment, without prior approval having been granted in writing obtained through an authorized RS&SC. THIS GUARANTEE AND WARRANTY ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED, OR STATUTORY. THERE ARE NO WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL THE AUTHORIZED RAYMOND SALES AND SERVICE CENTER BE LIABLE FOR INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES
